We enclose a Notice of Intention to Make a Proposal (the "NOI"), filed by the Company on July 5, 2010. As Trustee, we would like to take this opportunity to address some issues and perhaps answer some questions that you may have.

The Company has NOT filed for Bankruptcy nor is the Company in Receivership.

The Company will continue to operate and remain under its own management. The NOI creates a Stay of Proceedings, and allows the Company a period of up to thirty days to prepare and file a Proposal to its creditors. During this thirty-day period, the Trustee will be monitoring the business, preparing a report to the creditors on the business and financial affairs, and assisting the Company in preparing their respective Proposals.

Continued Operations

All amounts owed by the Company as at the date of the NOI will be dealt with as part of any proposal to be filed by the Company. Claims for goods supplied or services rendered subsequent to the filing of the NOI will be paid by the debtor in the ordinary course of business.

Filing a Claim

At this time, you do NOT need to file a Proof of Claim or report any discrepancies concerning the amount reported as owing to you by the Company. You will receive a Proof of Claim form to complete once the Company has filed its Proposal. All creditors and employees will have the opportunity to vote on the Proposal in person or by mail at a creditors' meeting held approximately three weeks after the Proposal is filed.


